Contest Structure

1. Eligibility

- ★ Open to single mothers ages 21+ residing in the United States.
- ★ Must be 21+ to consume alcoholic beverages during the event.
- ★ Mothers must be available to attend the Hats N Heels Tea Party™ Steeplechase Weekend in Metro Atlanta, GA, April 24–26, 2026.
- ★ Identification will be required at hotel check-in.

2. Contest Rounds

- ★ **Round One – Nominations: September 12th - November 15th**
 - A \$10 entry fee is required to nominate a single mom (self-nominations allowed).
 - Only one nomination per mother is necessary.
- ★ **Round Two – Voting: November 16th - December 15th**
 - \$2 per vote.
 - The 50 mothers with the most votes advance.
- ★ **Round Three – Final Voting: December 16th - January 31st**
 - \$1 per vote.
 - The 25 mothers with the most votes win the full weekend package.

3. Prizes

Each winning mother will receive:

- ★ Single-occupancy hotel accommodations (April 24–26, 2026).
- ★ Welcome Dinner (Friday evening).
- ★ Saturday Breakfast.
- ★ Transportation to Savoy Automobile Museum, 3 Savoy Lane, Cartersville, GA 30120 for professional photos.
- ★ Transportation to and from the Georgia Steeplechase at Kingston Downs, 500 Steeplechase Parkway, Cartersville, GA 30120 for the Derby Tea Party.
- ★ Derby Tea Party admission including food & beverage service.
- ★ Saturday Evening Closing Dinner.
- ★ Sunday Breakfast before check-out.
- ★ A childcare stipend provided to assist with costs for children's accommodations during the weekend.
